2. Update on Review of AARP Age and Dementia Friendly Summit – September 27 and 28

- e. Note Martha's Vineyard lead is a paid position (contributions of the 8 towns) unlike BrooklineCAN and AFC.

3. "All the Lonely People" film and campaign on loneliness

 - i. Ruthann Viewed first 4 minutes and it looks good and first time it will be shown in its entirety will be at the Coolidge.
 - ii. Same group that produced Gen Silent to great acclaim.
 - iii. BrooklineCAN decided to be one of the sponsors participating in ongoing activities in support of the isolated.
 - iv. This is the kickoff event of the campaign and activities.
 - v. Future projects bringing together multi-generational and intergenerational groups.
