1. "All the Lonely People" film and campaign on Ioneliness

- a. Ruthann Dobek reported on a successful showing and publicity.
- b. Article in the Globe (Dana Gerber) December 10 edition.
- c. Attendance: approximately 200 in person and 300 streaming.
- d. Included a panel discussion (local physician Dr. Jeremy Noble).
- e. Discussion included types and approaches to deal with loneliness including a "happy-to-chat bench".
- f. Proceeds were divided between local and national needs.
- g. Considered "1st time screening world-wide NOT "world premiere.
- h. Still editing, e.g., included mention of omicron.

2. American Rescue Plan Act of 2021 (ARPA)

- a. Update on state funding
 - i. Ruthann reported.
 - ii. State funds including \$100K for CoA passed but does not impact disbursement of local funding.
 - iii. Not clear on the process or priorities of local ARPA funding.
 - iv. Not clear as to the purpose and goals of Brookline Community Foundation with reference to ARPA.
- b. Review of Focus Group Wednesday Dec 1, 2:30pm
 - i. Focus group held at Senior Center December 1st.
 - ii. Notes taken by BFC but not distributed as of today.
 - iii. Jude offered to call Giselle for an update on the process.
 - iv. Two proposals submitted by C0A: Food insecurity and transportation.
 - v. CoA is working on proposal for a social worker.
- c. Susan Granoff reported on the Brookline Improvement Coalition:
 - i. BIC President Deborah Brown proposed a repair program for homeowners of low (& moderate?) income.
 - ii. "Grants" up to \$2,500 for those deemed eligible with "loan" for any amount beyond the \$2,500.
 - iii. BIC would like BrooklineCAN to be a partner in the program.
 - iv. Question: Is BIC infrastructure able to assist older residents?
 - v. Question: How does this one-time grant tie into a long term program?

3. BrooklineCAN Age-Friendly Business Program

- a. Discussion regarding future of the program
 - i. Recognize existing age-friendly businesses and encourage them and others to do more and join our AFB list.
 - ii. JF&CS would support a resource for AFB through June.
 - iii. Should AFB be a committee, sub-committee, or other?
 - iv. Ruthann will organize a group of people including Rosaline to review the AFB data base and reach out to new AFBs.
 - v. Someone from this committee should also be involved.
 - vi. Person involved should be a member or become a member of BrooklineCAN.
 - vii. Elenore will follow up with the group formed by Ruthann.
 - viii. Kathy pointed out that BrooklineCAN is the face of agefriendly Brookline to the world.
 - ix. David pointed out that AFB is one program in a broad array of age-friendly Brookline activities.
