Submitted by: Director of Finance and Council on Aging Director The Town's successful Senior Citizen Property Tax Work-Off Program currently allows 35 residents over the age of 60 years to reduce their real estate taxes by a maximum of \$1,875 annually, provided they meet certain income requirements. This article would adopt new state legislation approved last autumn allowing the maximum tax reduction for program participants to be \$2,000 annually. The Senior Citizen Property Tax Work-Off Program provides needed tax relief to seniors living on fixed incomes, while also providing the Town with skilled workers for specific tasks.
